Confidentiality

All work is treated in strict confidence and all staff sign confidentiality agreements. **SMARTdocs** can sign your confidentiality agreement or provide our own, on request. System Information

Our workflow platform at http://smartdocs.transcription-online.com is very simple and efficient for clients to use. The system allows you to log on 24/7 to upload audio files and download completed transcripts. You can also login to check the progress of your files. Audio files are automatically deleted after 90 days. All files (audio and transcripts) can be deleted on request after invoices have been paid. Once files have been deleted from the system they cannot be retrieved. Parts of a minute are rounded up to the next minute.

Files and Documents

We can transcribe most digital file formats. We also accept files on CD and DVD – please confirm with us prior to sending via post. All files are transcribed in Word, unless otherwise advised (eg, as PDF). You can supply templates or **SMARTdocs** will provide the appropriate layout and formatting. Any specific instructions for the typist must be advised in the notes box when uploading files (e.g. speaker names, jargon). It is the responsibility of the client not to upload the same audio file more than once. **SMARTdocs** takes all care to check that your files are not duplicates, but cannot guarantee catching it. If a file is uploaded twice so both are transcribed, the client will be charged for both files.

Payment terms:

Every organisation has different payment terms, we know!
